## **PUBLIC NOTICE**

The Ohio State Racing Commission will hold a public hearing for the purpose of accepting testimony on the proposed amended rule package containing rules found in Chapter 2, Chapter 4 and Chapter 7 of the Ohio Administrative Code.

These rules discuss permit holders' requirements in Standardbred horse racing. These rules were reviewed in accordance with the requirement of Ohio Revised Code 119.03 and have proposed as follows:

- Ohio Administrative Code 3769-2-14 titled Permit holder's enforcement obligations. This rule is being amended to require the permit holder to employ one person to each official position.
- Ohio Administrative Code 3769-4-58 titled Posting of Jockey Insurance Coverage. This rule is a new rule which requires the permit holder to post a summary of the jockey's health insurance in the jockey quarters.
- Ohio Administrative Code 3769-7-13 titled License required to ride. This rule is being amended that no jockey shall weigh more than 130 pounds.
- Ohio Administrative Code 3769-7-32 titled Jockey suspension. This rule is being amended to allow jockeys on the permit holder's grounds during their suspension.
