Pursuant to sections 3121.8911and 3125.25 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the rescission and amendment of the rules as identified below and of a public hearing thereon.

The following Ohio Administrative Code (OAC) rules are being proposed for rescission as a result of a review conducted in accordance with section 106.03 of the Revised Code (ORC), which requires five-year reviews of all state agency rules.

- Rule 5101:12-10-90.2, "New hire directory of employees," describes the process by which ODJFS enters the information described in division (A)(1) of section 3121.89.2 of the Revised Code into the new hire directory of employees. The rule is being rescinded as the provisions are stated in ORC.
- Rule 5101:12-10-90.3, "New Hire Directory of Independent Contractors," describes the actions ODJFS takes upon receiving a new hire report regarding a contractor, including entering the information into the new hire directory, and comparing the social security number of the contractor with the social security numbers of obligors in the Support Enforcement Tracking System (SETS). The rule also states that ODJFS shall use information from the new hire report for support establishment and enforcement purposes. The rule is being rescinded as the provisions are stated in ORC.

The following OAC rules are being proposed for amendment as a result of a review conducted in accordance with section 106.03 of the Revised Code (ORC), which requires five-year reviews of all state agency rules.

- Rule 5101:12-1-25, "Record retention, disposal, and destruction of fiscal, statistical, and administrative records," describes the retention and destruction of all records that relate to the child support program. The rule is being revised to clarify the retention period in paragraph (C).
- Rule 5101:12-10-90, "New Hire Reporting Program," identifies the federal law that requires Ohio to administer a new hire reporting program; contains definitions used in this rule and the supplemental rules; specifies that new hire reports are not public records. Changes from the existing rule include: corrected a typo in paragraph (B)(4) and clarified the language in paragraph (C).
