The rule specifies how the Board will document, track, prioritize and expedite the issuance of temporary licenses. The rule specifies the manner in which the Board will expedite an initial application for these licenses and permit based on the applicant's status as a member of the

military or veteran, or as the spouse or surviving spouse of a member of the military or veteran. The rule specifies the requirements for renewal of an expired license for military members or the spouse of a military member. The rule specifies the requirements for members of the military or the spouse of a military members to request an extension to complete continuing education.

## The following rule is being proposed as an amended rules:

4753-12-01 – Temporary licensure for members of the military and spouses; consideration of military experience and expedited licensure for military and spouses.

This rule specifies the requirements for a temporary audiology license, speech-language pathology license, conditional speech-language pathology license, audiology aide license, or speech-language pathology aide license for out of state active duty members of the military and spouses. The rule specifies how the Board will document, track, prioritize and expedite the issuance of temporary licenses. The rule specifies the manner in which the Board will expedite an initial application for these licenses based on the applicant's status as a member of the military or veteran, or as the spouse or surviving spouse of a member of the military or veteran. The rule specifies the requirements for renewal of an expired license for military members or the spouse of a military member. The rule specifies the requirements for members of the military or the spouse of a military members to request an extension to complete continuing education.
