Pursuant to section 5107.05 and Chapter 119 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment, or rescission of the rule or rules as identified below and of a public hearing thereon.

Rule 5101:1-3-07, entitled Ohio Works First: Evidence of Age, Citizenship, and Identity, is being proposed for amendment because of a five-year review. This rule describes the age, citizenship, and identity verification requirement for the Ohio Works First program. The changes to the rule include: paragraph (B) has been updated with verifications that are acceptable as proof of identity; and minor language changes were made for clarity.

Rule 5101:1-3-09, entitled Ohio Works First: Social Security Number Requirement, is being proposed for amendment because of a five-year review. This rule describes the social security number requirement for the Ohio Works First program. The changes to the rule include: removal of form revision dates in paragraph (C) as a result of Senate Bill 221 of the 132<sup>nd</sup> General Assembly that amended incorporation by reference requirements contained in section 121.71 to 121.75 of the Ohio Revised Code; corrected the term RSDI to read "retirement, survivors, and disability insurance (RSDI); and minor language changes were made for clarity.
