The following rules are proposed for amendment:

Soil and Water Ch 2-02 Notice of Public Meeting

OAC 901:13-2-02: ODA is proposing to rescind one rule and replace it with a new rule as required by the Legislative Service Commission when amending approximately more than fifty per cent of a rule, the agency should rescind the existing rule and enact a new rule bearing the same rule number as well as revisions to the text.

Plant Health Ch 30 Invasive Plant Advisory Committee

OAC 901:5-30-02: ODA is proposing to amend one rule as part of the statutory five-year rule review process.

Food Safety Ch 7 Fish and Fishery Products

OAC 901:3-7-01 through 11: This rule package consists of eleven rules which ODA is proposing to rescind and replace with four new rules as a part of the statutory five-year review process.

Persons affected by the proposed rules may appear and be heard in person, by an attorney, or both, or may present their position, arguments, or contentions, orally or in writing. Persons may offer and examine witnesses and present evidence tending to show that the proposed rules will be unreasonable or unlawful if enacted.
