Pursuant to section 5107.05 and Chapter 119 of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment, or rescission of the rule or rules as identified below and of a public hearing thereon.

Rule 5101:1-3-12.8, entitled Providing Child Care Services to an Individual Who is Participating in a Community Service Program, is being proposed for amendment because of a five year review. This rule describes providing child care services to an individual who is participating in a community service program for the Ohio Works First program. The changes to the rule include: The title to paragraph (A) has been amended to "Which section of the Revised Code applies to providing child care services to an individual who is participating in a community service program?"; Paragraph (A)(1) was removed and replaced with "Section 5107.05 of the Revised Code authorizes the director of job and family services to adopt rules necessary to comply with Title IV-A, Title IV-D, federal regulations, state law and the state plan; Paragraph (A)(2) was revised and replaced with "The county agencies shall administer the work activity programs in accordance with requirements contained in this rule and not in accordance with sections 5107.40, 5107.541, and 5107.60 of the Revised Code. All applicable requirements contained in the Revised Code sections referenced have been incorporated into this rule; Paragraph (A)(3) was removed and added to paragraph (A)(2) for clarity; The rule was put into question-and-answer format; Minor languages changes were made for clarity.
