Pursuant to sections 5104.016, 5104.017, 5104.018, 5104.0110 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the adoption, amendment, or rescission of the rule or rules as identified below and of a public hearing thereon.

Rule 5101:2-12-08, entitled "Employee and child care staff member requirements for a licensed child care center" is being proposed for amendment. This rule sets forth the qualifications for employees and child care staff members in a licensed child care center. The changes to the rule are as follows: to lower the minimum age requirement of child care staff members from 18 years old to 16 years old, allow high school students and graduates to work in child care if they are enrolled in specific child care technical or training programs, and establish limitations on child supervision and safety for high school child care staff members.

Rule 5101:2-13-08 entitled "Employees and child care staff members responsibilities and qualifications for a licensed family child care provider" is being proposed for amendment. This rule sets forth the qualifications and responsibilities for all staff members and employees in a family child care home. The changes to the rule are as follows: to lower the minimum age requirement of child care staff members from 18 years old to 16 years old, allow high school graduates under the age of 18 to work in child care, and establish limitations on child supervision and safety for child care staff members under age 18.
