# NOTICE OF INTENTION TO HOLD A PUBLIC HEARING ON THE AMENDMENT, RESCISSION AND REPLACEMENT OF ADMINISTRATIVE RULES FOR THE DIVISIONS OF WATERCRAFT & WATERWAYS AND NATURAL AREAS & PRESERVES

In compliance with the provisions of S.B. 156 of the 135<sup>th</sup> General Assembly, the Ohio Department of Natural Resources hereby gives notice of intention to adopt, amend, or rescind the following rules in accordance with sections 119.03, 1517.02, and 1546.04 of the Ohio Revised Code:

### To be rescinded:

1501:47-4-01 Application and definitions.

### To be amended:

1501:17-1-02 Definitions.

To be amended and renumbered:		Replacement number and tagline:	
1501:47-4-02	Visitation, use, and general prohibitions.	1501:17-1-04	Visitation of scenic river lands, restrictions.

### **SUMMARY:**

The Divisions are proposing revisions to the Ohio Administrative Code that amend and renumber rules related to the administration of the Ohio Scenic Rivers program to comply with S.B. 156 that transfers administration of the Scenic Rivers program from the Division of Parks & Watercraft to the Division of Natural Areas & Preserves. These changes do not substantially change regulations regarding use of scenic river lands.

A public hearing on the proposed rule rescissions, adoptions, and amendments will be held at 2:00 p.m. on Tuesday, September 10, 2024 in the H-1 Conference room at ODNR Headquarters which is located at 2045 Morse Road in Columbus, Ohio.
