### Legal Notice

The State Board of Education will hold a public hearing regarding the rule actions listed below, on October 15, 2024, at 9:00 a.m. at the State Board of Education, Third Floor, Room 3, 30 West Spring Street, Columbus, Ohio, 43215.

#### **OAC Chapter 3302-24-03 Pre-Service Teacher Permit (1 Rule)**

OAC 3302-24-03 requires anyone in an educator preparation program to obtain this permit before they can be in a PK-12 classroom. This rule is being adopted to establish standards for the permit created under Ohio Revised Code section 3319.0812.

#### **OAC Chapter 3302-24-15 Provisional educator license for teachers in STEM schools (1 Rule)**

OAC 3302-24-15 provides the standards for issuing a provisional STEM educator license pursuant to Ohio Revised Code section 3319.28. This rule is being amended to reflect legislative changes stemming from House Bill 33 of the 135<sup>th</sup> General Assembly (HB 33).

#### **OAC Chapter 3302-24-19 Alternative Resident Educator Licenses for Teaching in Grated Pre-Kindergarten to twelve (1 Rule)**

Provides the standards for issuing an alternative resident educator license. This rule is being amended to reflect changes stemming from HB 33.

#### **OAC Chapter 3302-24-27 Early College High School Educator License (1 Rule)**

OAC 3302-24-27 provides the standards for issuing and early college high school educator license. The rule is being amended to change the rule number, but no substantive changes have been made to the rule.

#### **OAC Chapter 3302-24-28 Interim License (1 Rule)**

OAC 3302-24-28 was adopted in 2019 with the express intention for these licenses to not be issued beyond July 1, 2021, and the original purpose for which it was adopted was subsequently repealed by the General Assembly. This rule is being rescinded, as it no longer serves a useful purpose.

#### **OAC Chapter 3302-25-10 One-year instructional assistant permit; renewal thereof (1 Rule)**

OAC 3302-25-10 provides the standards for issuing a one-year instructional assistant permit and renewals thereof. The rule is being amended to change the rule number, but no substantive changes have been made to the rule.

#### **OAC Chapter 3302-26-01 Examinations for educator licensure (1 Rule)**

OAC 3302-26-01 sets forth the requirements for assessments pertaining to licenses issued by the State Board of Education. This rule is being amended to reflect legislative changes stemming from HB 33.

**OAC Chapter 3302-89 Territory Transfer (4 Rules)**

OAC 3302-89 sets forth the process for transfers of territory under ORC 3311.06 and 3311.24. These rules are being amended to reflect legislative changes stemming from HB 33.
