Rule 5101:2-5-05, entitled Agency appeal of findings of noncompliance, is being proposed for amendment to implement a continuous certification process for foster care agencies and for the five year review. This rule provides guidance to agencies how to file an appeal of an agency finding. The system reference was changed.

Rule 5101:2-5-08, entitled PCPA and PNA governance and administration, is being proposed for amendment to implement a continuous certification process for foster care agencies and for the five year review. This rule provides guidance to agencies on the structure and requirements of their governing body. Changed the audit rule reference in paragraph (A).

Rule 5101:2-5-11, entitled Complaint handling, is being proposed for amendment to implement a continuous certification for foster care agencies and for the five-year review. This rule provides guidance to agencies on the processing of complaints made about the agency. Paragraph (H) was amended to remove the term "denial" as duplicates statute and are directives for DCY.

Rule 5101:2-5-18, entitled Waivers and variances, is being proposed for amendment to implement a new continuous certification process for foster care agencies and for the five-year review. This rule provides guidance to agencies on how to request foster home and agency waivers. Paragraph (B) was amended to remove the reference to a certification period.

Rule 5101:2-5-30, entitled Foster care amendments, is being proposed for amendment to implement a continuous certification process for foster caregivers and for the five-year review. This rule provides guidance to agencies on what needs to be entered as an amendment to the
