NOTICE OF PUBLIC HEARING

Oral or written testimony may be presented by any person affected by the proposed action.

The following rules are being proposed as amended rules:

4747-1-02: Definitions and interpretations

This rule specifies the definitions and interpretations for hearing aid fitting and hearing aid dealing in the state of Ohio. The public purpose of this rule is to ensure the terms and definitions for the scope of practice for hearing aid fitting and hearing aid dealing are clear to ensure consumer protection. The nature of the adverse impact from this rule will be minimal because these rules merely define terms for greater clarity to the rules under which the terms are referenced. There are no new regulations being proposed under the proposed amendments to this rule.

4753-6-01: Screening

This rule specifies the requirements for individuals licensed under Chapter 4753 performing audiology and speech-language pathology screenings. The public purpose of this rule is to ensure screenings are appropriately performed to identify consumers who are suspected of having communications disorders. The proposed amendment is clean-up in nature to replace the antiquated reference to "Public Health Council" which is no longer in existence under the Ohio Department of Health, to the agency's current name, "Ohio Public Health Advisory Board."
