Pursuant to section 3125.25 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for amendment as a result of a review conducted in accordance with section 106.03 of the Revised Code (ORC), which requires five-year reviews of all state agency rules.

- Rule 5101:12-60-05.1, "Initiating of an Administrative Review," describes the criteria to initiate an administrative adjustment review. Changes to this rule include clarifying in paragraph (A) that the administrative review is of the order, not the case, minor language changes throughout the rule for clarity and adding ORC 3119.76 to the authorization section of the rule.
- Rule 5101:12-60-05.3, "The Administrative Review," describes the responsibilities of the CSEA when conducting the administrative review. Changes to this rule include amending paragraph (A) for clarity purposes, removing restrictive language throughout the rule and adding ORC 3119.76 to the authorization section of the rule.
- Rule 5101:12-60-05.5, "Notice of Hearing Rights," describes the hearing rights of the parties. The rule replaces rescinded OAC rule 5101:12-60-05.5. Changes to this rule include correcting a spelling error in paragraph (A), removing restrictive language from the rule and adding ORC 3119.76 to the authorization section of the rule.
- Rule 5101:12-60-05.6, "CSEA Administrative Adjustment Hearing Process," describes the administrative adjustment hearing process. Changes to this rule include updating the ORC references in paragraph (B)(1), removing restrictive language throughout the rule, adding language to paragraphs (E) and (M)(2) and adding ORC 3119.76 to the authorization section of the rule.
