Pursuant to sections 3111.34, 3111.67, 3125.25 and Chapter 119. of the Ohio Revised Code, the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for amendment to clarify the instructions when completing the paternity affidavit (JFS 07038) and to update the effective date.

- Rule 5101:12-01-99, "Chapter 5101:12-1 forms Ohio support enforcement program," contains a compilation of forms with their effective or revised effective date, referenced within various rules contained within division 5101:12 of the Administrative Code, but first cited within Chapter 5101:12-1 of the Administrative Code. This is being revised to update the revision date of the JFS 07038.
- Rule 5101:12-40-01, "Distribution of Paternity Acknowledgement Affidavit and Brochure,"
 describes that the Ohio Department of Job and Family Services (ODJFS) shall make the Paternity
 Acknowledgment Affidavit and the paternity brochure available to entities and any individual that
 requests such document. Changes to this rule include: added a requirement to also make available the
 notice and instructions for completing the acknowledgment of paternity affidavit to persons that
 request such document and removed the restrictive language throughout the rule.
- Rule 5101:12-40-30, "Central Paternity Registry," describes the requirements that the Central Paternity Registry (CPR) must follow in maintaining a birth registry. Changes to this rule include: removed of the requirement for a JFS 07038 received by the central paternity registry (CPR) to be completed on legal sized paper and removed the restrictive language throughout the rule.
- Rule 5101:12-40-99, "Chapter 5101:12-40 forms paternity establishment," contains a compilation of forms with their effective or revised effective date, referenced within various rules contained within 5101:12 of the Administrative Code, but first cited within Chapter 5101:12-40 of the Administrative Code. Changes to this rule include: added the JFS 07038-I, "Notice and Instructions for Completing the Acknowledgment of Paternity Affidavit" and added the form's effective date.
