These rules are being amended to perform a five-year review in accordance with Ohio Revised Code section 106.03. Additional amendments reflect an update within House Bill 33 of the 135th General Assembly, authorizing an expanded use of 9-passenger vans to transport students. Lastly, amendments to rules 3301-83-05, 83-09, 83-10, 83-13, and 83-19 implement certain recommendations made by the Ohio School Bus Safety Working Group.
