Pursuant to section 3125.25 and Chapter 119. of the Ohio Revised Code (ORC), the director of the Ohio Department of Job and Family Services gives notice of the department's intent to consider the amendment of the rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for amendment as a result of a review conducted in accordance with section 106.03 of the ORC, which requires five-year reviews of all state agency rules.

- Rule 5101:12-1-51, "Mandatory CSEA Fiscal Reports," describes the requirements for child support enforcement agencies (CSEA) and the office of child support (OCS) to submit required financial reports to the office of fiscal and monitoring services within the Ohio department of job and family services (ODJFS. Changes to the rule include: updated the name of the federal office of child support in paragraph (A), and removed the restrictive language.
- Rule 5101:12-50-34, "Passport Denial and Reinstatement," describes the passport denial and the reinstatement process of an obligor who has met the criteria. Changes to the rule include: updated the name of the federal office of child support in paragraph (A), and removed the restrictive language.

The following rule is being revised to update the effective date of some forms that are referenced in this rule.

• Rule 5101:12-57-99, "Chapter 5101:12-57 Forms – Enforcement of Medical Support Provisions," contains a compilation of forms within division 5101:12 of the Administrative Code, but first cited within Chapter 5101:12-57 of the Administrative Code. Changes to this rule include amended the revision date of JFS 04031, JFS 04032, JFS 04033, JFS 07053 and JFS 07058.
