In accordance with Chapter 119 of the Revised Code (R.C.), the Director of the Ohio Department of Health announces a Public Hearing at the date and time listed above to hear comments regarding the following action:

3701-10-1 - Breast and Cervical Cancer Project Cost Sharing

Ohio Administrative Code 3701-10-01 establishes requirements concerning cost sharing measures for the Ohio Breast and Cervical Cancer Project (BCCP), including requirements for eligibility, documentation of cost sharing, and reimbursement. The rule is amended to state that a provider will accept reimbursement from a woman's health insurance if a provider is within twenty miles of her residence and that, if no providers are available within twenty miles of a woman's residence, she will be scheduled with the closest available BCCP provider.

Hearing and Contact Information:

In accordance with ORC Section 119.03 (D), any person affected by the proposed action may appear and be heard. Any such person may be represented by an attorney, present their positions, arguments, or contentions orally or in writing, may offer witnesses, and may present evidence tending to show that the proposed rule, if adopted or effectuated, will be unreasonable or unlawful. To aid in organizing the meeting, any persons intending to testify at the Public Hearing or planning to observe are encouraged to email Alicyn.Carrel@odh.ohio.gov immediately.

The public hearing is open to the public and will be held in-person in Basement Conference Room A at 35 E. Chestnut Street, Columbus, Ohio on May 8, 2025 at 11:30am.
