Public Notice Public Hearing Scheduled For Proposed Rulemaking Governing Water Quality Standards

Notice is hereby given that the Director of Environmental Protection, under the authority of Sections 6111.03, 6111.031, 6111.041, 6111.13 of the Ohio Revised Code and in accordance with Chapter 119, proposes to amend the following water quality standards rule of the Ohio Administrative Code:

Rule Title Rule #

3745-1-38 Variances from water quality standards for point sources.

This rule addresses water quality standards regulations.

The purpose of this rule making is to complete the five-year rule reviews of a water quality standards rule as required by Ohio law.

The public comment period will run until June 5, 2025. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rule on June 5, 2025 at 2 p.m. The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rule if participating virtually and verbally if participating in person.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rule making.
