## Public Notice Proposed Rulemaking Governing Record Maintenance

Notice is hereby given that the Director of Environmental Protection, under the authority of Section 6109.04 of the Ohio Revised Code and in accordance with Chapter 119, proposes to amend the following rule of the Ohio Administrative Code:

Rule # Title

3745-81-33 Record Maintenance

This rule has been reviewed pursuant to the five-year rule requirements set forth in ORC 106.03. Potential revisions include:

- Minor language corrections to improve clarity and continuity throughout the chapter.
- Provide an option for the director to extend the minimum retention period on a caseby-case basis.

The public comment period will run until September 5, 2025. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding virtual public hearing and in-person on the rules on September 5, 2025, at 10:30am. The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rulemaking.
