**NOTICE OF PUBLIC HEARING AND RULES REVIEW**

Pursuant to Ohio Revised Code Section 4301.06, the Ohio Liquor Control Commission is required to hold no fewer than four public hearings each year to hear general comments, complaints, and suggestions as to its policies, adopted pursuant to Chapters 4301 and 4303 of the Ohio Revised Code, to consider other business and procedures of the Commission, and for the dissemination of information to the public.

Notice is also hereby given that the Commission, in accordance with Ohio Revised Code Chapter 119, has completed a review of the following Administrative Rules, some of which are subject to five-year review:

**Proposed Amended:**

OAC 4301:1-1-67      Sales reports of A-1 permit holders.

**Proposed Rescission:**

OAC 4301:1-1-66      Advertising of proposed rules.  
OAC 4301:1-1-68      Sales reports of B-1 permit holders.

**Proposed No-Change:**

OAC 4301:1-1-11      Permits, procedure where quota is filled.

The Commission proposes to amend OAC 4301:1-1-67 (Rule 67) to include B-1 liquor permit holders who are currently subject to the same requirements as an A-1 permit holder, but under a different rule (OAC 4301:1-1-68). With the inclusion of B-1 permit holders in Rule 67, the Commission in turn proposes rescission of Rule 68. Finally, the Commission will receive any comments or testimony concerning its review of the following Administrative Rules:

OAC 4301:1-1-16      Closing authority.  
OAC 4301:1-1-52      Entertainment – prohibition against improper conduct.

**The Commission will conduct the public hearing at 9:00 a.m., on Thursday, September 11, 2025, at the Ohio Department of Public Safety Building, 1970 West Broad Street, Columbus, Ohio 43223.**

At the public hearing, any person affected by the proposed action may appear and be heard in person, by the person's attorney, or both, or may present comments in writing. Additionally, anyone who wishes to speak to the issues of Commission policy or rules or wishes to make comments to the Commission relating to its business may do so at this time.
