Pursuant to section 5180.21 and in accordance with Chapter 119 of the Ohio Revised Code, the Ohio Department of Children and Youth gives notice of the department's intent to consider the rescinding and adopting of the rules as identified below and of a public hearing thereon.

The following OAC rules are being proposed for rescission, adoption, and modification as a result of their transfer to DCY and requirements of House Bill 7 (HB 7) of the 135<sup>th</sup> General Assembly.

OAC rule 5180:8-3-05, entitled "Provision of home visiting services", outlines the manner in which home visiting services are provided to families, outlines timelines for offering services, and provides information on when a family would exit services. The new language updates statutory and agency references. It also adds a new priority group of families involved with child welfare in accordance with HB 7 of the 135th General Assembly. It is being adopted as a new rule to replace OAC rule 5180-8-02.

OAC rule 5180:8-3-10, entitled "Central intake and referral system", outlines the responsibilities of the central intake and referral vendor in terms of recruiting and enrolling families in home visiting services. The new language updates statutory and agency reference. It also adds a new priority group of families involved with child welfare in accordance with HB 7 of the 135th General Assembly. It is being adopted as a new rule to replace OAC rule 5180-8-10.

OAC rule 5180-8-05, entitled "Provision of home visiting services", outlines the manner in which home visiting services are provided to families, outlines timelines for offering services, and provides information on when a family would exit services. This rule is being rescinded and replaced by new OAC rule 5180:8-3-05.

OAC rule 5180-8-10, entitled "Central intake and referral system", outlines the responsibilities of the central intake and referral vendor in terms of recruiting and enrolling families in home visiting services. This rule is being rescinded and replaced by new OAC rule 5180:8-3-10.
