PUBLIC NOTICE

The Ohio State Racing Commission will hold a public hearing for the purpose of accepting testimony on the proposed rule package containing amended rules OAC 3769-15-01, 3769-15-02, 3769-15-03, 3769-15-04, 3769-15-05, 3769-15-06, 3769-15-07, 3769-15-10, 3769-15-11, 3769-15-12, 3769-15-13, 3769-15-16, 3769-15-17, 3769-15-19, 3769-15-29, 3769-15-30, 3769-15-31, 3769-15-32, 3769-15-33, and 3769-15-99 found in Chapter 3769-15 of the Ohio Administrative Code.

These rules discuss standardbred racing rules. These rules were reviewed in accordance with the requirements of Ohio Revised Code 119.03 and have been proposed as follows:

3769-15-01: This rule states the racing secretary's duties. This is amended for easier readability.

3769-15-02: This rule states that a license is required to race a horse. This is amended to remove reference to a rescinded rule.

3769-15-03: This rule states that you cannot participate if you are disqualified. This is amended for easier readability.

3769-15-04: This rule states who may enter and that all owners need to be listed. This is amended for easier readability.

3769-15-05: This rule is the requirement for stable names. This is amended for easier readability.

3769-15-06: This rule states that anything contained within an entry may not be changed.

This is amended for easier readability and to clarify the expectations of the trainer.

3769-15-07: There is no entry fee to enter a race unless the conditions require it. This is being amended for easier readability.

3769-15-10: This rule says a horse has to be registered. It is amended for easier readability, and to correct a previous spelling error.

3769-15-11: This rule states that a horse has to be identified and what the requirements are. It is amended for easier readability.

3769-15-12: The horse has to be identified, and it is the responsibility of the person(s) in charge of the horse. This is amended for easier readability.

3769-15-13: The racing secretary receives the entry fees. This is amended for easier readability.

3769-15-16: This rule states which horses are ineligible to be entered. This is amended for easier readability and to prevent two-year old horses from racing too frequently.

3769-15-17: This states that engagements attach to the horse, and with a private sale, the seller has to notarize the bill of sale. This is amended for easier readability.

3769-15-19: This rule states how horses are entered into a race. It is amended for easier readability and to state that the claiming price is not distributed to the previous owner until the transfer of ownership after the claim occurs.

3769-15-29: This rule states that horses have to have a qualifying race prior to initial entry at that gait, and how they are charted. It is amended for easier readability and to remove duplicity.

3769-15-30: This rule describes how entries are made and their conditions of acceptance. This is amended for easier readability.

3769-15-31: This rule states how preference and also-eligible horses are handled. This is amended to remove the requirement that a fair must request a waiver if that fair does not want to use preference.

3769-15-32: This rule states what the Judges list is and how a horse may be placed on it. It is amended for easier readability.

3769-15-33: This rule states what the program director does. It is amended for easier readability.

3769-15-99: This rule states the penalties the commission may impose. It is amended for easier readability.

The Hearing will be held on: November 19, 2025 at 8:00 a.m.

The hearing will be conducted in accordance with Chapter 119 of the Ohio Revised Code. All interested parties are invited to attend the hearing and present oral and/or written testimony.
