Public Notice Proposed Rulemaking Governing Disadvantaged Community Loans

Notice is hereby given that the Director of Environmental Protection, under the authority of Section 6109.04 of the Ohio Revised Code and in accordance with Chapter 119, proposes to amend the following rules of the Ohio Administrative Code:

Rule # Title
3745-88-01 Definitions.
3745-88-02 Disadvantaged Community Loans.

This rule has been reviewed pursuant to the five-year rule requirements set forth in ORC 106.03. Potential revisions include, removing redundant information that is in the drinking water assistance fund authorized under section 6109.22 of the Revised Code.

The public comment period will run until December 1, 2025. A public hearing on this proposed rulemaking will be held to consider public comments in accordance with Section 119.03 of the Ohio Revised Code. Ohio EPA will be holding an in-person and virtual public hearing on the rules on December 1, 2025, at 11:15am. The in-person hearing will be at the same time and date and will be located at Ohio EPA, Suite 700, 50 W. Town Street, Columbus, Ohio 43215. During the hearing, the public may submit written comments on the record about the proposed rules if participating virtually and verbally if participating in person.

Oral testimony may be limited to five minutes, depending on the number of persons testifying. All interested persons are entitled to attend or be represented and to present oral and/or written comments concerning the proposed rulemaking.
