In accordance with Chapter 119 of the Revised Code, the Ohio Department of Agriculture will conduct a public hearing for the purpose of soliciting comments regarding the adoption, amendment and recission of rules.

The public hearing will **be from 10:00 am to 10:30 am** or until all parties in attendance have had the opportunity to be heard.

The following rules are proposed for amendment:

## Dairy Division- Dairy License; Registration; License or Registration Fees; Milk Inspection Fees

**OAC 901:11-1-04** This rule package consists of one amended rule which ODA is proposing as a result of amendments to suspension periods and that the director may order additional sampling and testing when a potential problem exists.

## Animal Health Division- Ch 25 Livestock Brands- Five Year Rule Review

**OAC 901:1-25-06** This rule package consists of one amended rule which ODA is proposing as a result of a statutory five-year rule review. The rule is being proposed with no changes made; however, the rules that are listed under the "Rule Amplification" section are incorrect requiring this rule to be submitted as an amended rule. ORC 917.02 and 917.03 will be changed to ORC 947.02 and 947.03.
