## FEDERAL MEDICAID NOTICE OHIO DEPARTMENT OF MEDICAID

Pursuant to 42 CFR 447.205, the director of the Ohio Department of Medicaid (department) gives notice of the department's intent to implement methods and standards for Medicaid payment for three new services, Mobile Response Stabilization Service (MRSS), Child and Adolescent Needs and Strengths (CANS) assessment, and Intensive Care Coordination (ICC)/Moderate Care Coordination (MCC).

The following 1905(a) services are involved in the coverage of CANS:

- Outpatient Hospital Services
- Ambulatory Health Care Clinics
- Early and Periodic Screening Diagnosis of Individuals Under 21 Years of Age and Treatment Conditions Found
- Physicians' Services
- Non-Physician Licensed Behavioral Health Practitioners
- Physician Assistants' Services
- Advanced Practice Nurses' Services
- Mental Health Rehabilitative Services
- Substance Use Disorder Services

The following 1905(a) services are involved in the coverage of MRSS:

- Outpatient Hospital Services
- Early and Periodic Screening Diagnosis of Individuals Under 21 Years of Age and Treatment Conditions Found
- Mental Health Rehabilitative Services
- Substance Use Disorder Services

The following 1905(a) service is involved in the coverage of ICC/MCC:

• Targeted Case Management Services

An independent rate build-up methodology was used to develop the payment rates which took into consideration the resources required for providers to deliver the service. Implementation of this change in the methods and standards for setting payment rates is expected to increase annual aggregate expenditures for MRSS by approximately \$4.9 million, for CANS approximately \$8.6 million, and for ICC/MCC, approximately \$132.5 million.
