board.

- (A) The STABLE account advisory board has adopted this rule in compliance with, and under the authority of, division (F) section 121.22 of the Revised Code and division (C) section 113.56 of the Revised Code.
- (B) The STABLE account advisory board shall meet at least four times each year quarterly or more frequently at the call of the chairperson. Any person may determine the time and place of all regularly scheduled meetings and the time, place, and purpose of all <u>scheduled and</u> special meetings by: <u>consulting the Ohio treasurer of state's website</u> or calling the Ohio treasurer's office at 614-466-2160 during regular business hours.
 - (1) Consulting the Ohio treasurer of state's website; or by
 - (2) Calling the Ohio treasurer of state's office at 614-466-2160 during regular business hours; or by
 - (3) Writing to the "STABLE Account Advisory Board, c/o Ohio Treasurer's Office, STABLE Account, 30 East Broad Street, 10th Floor, Columbus, Ohio 43215", and submitting an electronic mail address, by which all notice of meetings will be sent.
- (C) The chairperson or their designee shall maintain a list of <u>Any person, including</u> news media representatives, who have, in writing, requested <u>may obtain</u> notice of all <u>scheduled and</u> special and emergency meetings of the STABLE account advisory board <u>by sending a written request to the address listed above</u>. Such written requests shall list the media representative's include the person's contact information and electronic mail address. Such requests shall be sent to "STABLE Account Advisory Board c/o Ohio Treasurer's Office, Communications Department, 30 East Broad Street, 9th Floor, Columbus, Ohio 43215." Any media request shall be effective for one year from the date of filing with the chair. - (D) Any person, upon request and payment of a reasonable fee, may obtain advance notification of all meetings. Notification will be mailed to all subscribers who request to be on the mailing list for advance notification.
