Chapter 4785. of the Revised Code establishes a licensing requirement for elevator mechanics and elevator contractors providing conveyance services. The Chapter also

includes the minimum qualifications an applicant must demonstrate to qualify to obtain each type of license. This rule establishes the criteria that the Division may use to deny an initial applicant or renewal applicant under Chapter 4785. of the Revised Code and rules promulgated thereunder.

The rule establishes the reasons an initial application or renewal application for an elevator contractor's license or elevator mechanic's license may be denied, including reference to specific criminal offenses that may disqualify an applicant from obtaining a license as provided for in section 9.79 of the Revised Code.

The rule references rules in the Ohio Administrative Code, which are exempt from the requirements of section 121.71 through 121.74 of the Revised Code. R.C. 121.75(A) (1)(d).

But only indirectly. For example, the rule permits an application for an elevator mechanic's license to be denied if the applicant has engaged in fraud, misrepresentation, or deception in the conduct of business. While engaging in such fraud might be revenue generating for the business, and not engaging in fraud might increase the expenses of the lines of business to which this rule applies, protection of customers of such licensees from fraud justifies any purported increase in the costs of business for licensees.
