Pursuant to section 119.032 of the Revised Code, ODA is reviewing the rules of Chapter 173-40 of the Administrative Code because every agency is required to review each of its rules at least once every five years.

This proposed amended rule addresses an issue . All amendments, but one, are non-substantial and do not change the intent or function of the program. One amendment, however, reduces the number of days that an individual may receive PASSPORT home care services while on loss-of-Medicaid-eligibility status from ninety days to sixty days, with exception.

ODA estimates that there is no cost of compliance to directly affected persons associated with the proposed amendment to this rule, unless that person is unable to receive the temporary PASSPORT home care services offered to those on loss-of-Medicaid-eligibility status after sixty, but less than ninety days, since the proposed amended rule reduces the number of days that this temporary service will be provided from ninety days to sixty days. Such a person would need to provide

comparable home care at their own expense or the expense of another program, such as the programs funded through the Older Americans Act; or, such a person would need to consider other options, such as a nursing facility.
