Proposed changes include: removal of regulatory restriction terms "may not", "shall", and "prohibit"; (C) (3) remove ".", add ";", add "and" at end of sentence; (C)(4) add new section with language "Packaged food as specified under paragraph (E) of rule 3717-1-03.3 of the Administrative Code."; (D)(2)(c)(v) remove "that".
