This rule filing is based on a R.C. 119.032 rule review of Ohio Administrative Code Chapter 4501:2-10. Proposed changes are to update language and include reference to provisions of a recently effective federal law.

This rule sets forth requirements and limitations for agencies that operate a terminal

accessing NCIC. A proposed change in paragraph (C) deletes "ODPS" from the reference to ODPS/LEADS intranet. Proposed new paragraph (I) addresses the Adam Walsh Child Protection and Safety Act of 2006 which allows access to FBI criminal history record information (CHRI) by governmental social service agencies with child protection responsibilities. To enable identification of NCIC and CCH/III transactions conducted pursuant to section 151 of the Adam Walsh Child Protection and Safety Act and to facilitate state and federal compliance audits, it requires that agencies that meet NCIC requirements use a prescribed code for inquiries made for those agencies.
