The definitions

for this chapter relate to standards for MTO organizations, including record-keeping, health and safety requirements, communications, vehicle maintenance, inspections, investigations, and disciplinary grounds. Amendments include adding seven definitions, deleting one regulatory restriction, and correcting words that do not need to be capitalized. The comment referencing rule 4766-2-18 is deleted.
