Clarification to paragraph (2)(e) and (2)(g) regarding a culturally competent qualified professional for assessments and documentation of a child's diagnoses. Further clarification was added to the rule when adopting a child without AA and documentation requirements in paragraph (A)(3)(a). The rule has been amended to remove the revision date from the form(s) referenced in the rule.
