This rule is proposed for amendment as a result of the five-year review.

OAC rule 5101:2-49-13 entitled "Termination of Title IV-E Adoption Assistance (AA)" outlines the circumstances that result in the termination of an AA agreement. New language was added to the rule in paragraph (B) when the JFS 01451-B "Title IV-E Adoption Assistance Annual Assurance of Legal Responsibility, School Attendance and Eligibility for Continued Medicaid Coverage" is not to be used as a criterion for termination when the form is not returned to the PCSA. Grammatical changes were made in paragraph (C)(1) through (C)(4). Additional language was added in paragraph (D)(1) to define enlistment as the date of report for active duty. Inclusion of the JFS 01452 "Notice of Adverse Action for Title IV-E Adoption Assistance" in paragraph (E) of the rule when the PCSA proposes to terminate the AA subsidy. Clarification in paragraph (F)(4) was made to the rule when a state hearing is not made timely. The rule has been amended to remove the revision date from the form(s) referenced in the rule.
