This rule provides guidance to agencies on the various types of certifications for foster care agencies. Paragraph (E) was amended to establish a new initial certification period of four years. Paragraph (J) was added to address agency audits as required by statute. There is a one-time permission for an extension of the timeframe for submission of the agency audit. Paragraph (F) was added to describe a continuous certification status. New paragraphs (J)(K)(L) and (M) were moved here from rule 5101:2-5-04 as rule 5101:2-5-04 had been rescinded.
