This rule sets forth requirements for ODJFS in conducting a complaint investigation and informs agencies regulated by ODJFS of the department's authority to seek injunctive relief in certain situations. Consistent with HB 117, the proposed amendments to the rule allow ODJFS to seek injunctive relief when the department has issued a proposed adjudication order to deny renewal of or revoke an agency's certificate to prevent the agency from receiving additional children into care or removing children from the agency's care when the department has evidence that the life, health or safety of one or more children is at imminent risk.
