The policy for reinstating an application when an assistance group takes a required action within sixty days of filing an application has changed. Individuals are no longer required to file a new application if they request and complete an interview within sixty days after filing an application.

This rule sets forth the timeliness standard for processing an application and benefit issuance. The language in paragraph (B)(1) which required an applicant to file a new application if an interview was not completed in the initial thirty days has been removed.
