The federal changes allow agencies to receive federal reimbursement for Child Welfare prevention services that were not available through the current Title IV-E processes. Now these services and federal reimbursement are allowable through The Family First Prevention Services Act (FFPSA), enacted as part of Public Law (P.L.) 115-123, authorized optional Title IV-E prevention services funding for time limited prevention services for mental health, substance abuse, and in-home parent skill based programs for children or youth who are candidates for foster care, pregnant or parenting youth in foster care, and the parents or kin caregivers of those children and youth.
