Complaint procedure

The proposed changes update to reflect the Division's process when receiving a complaint against a cemetery that is not registered but should be registered.

<u>1301:13-5-01</u> – Division staff recommends that this rule be amended.

Sale or transfer of cemetery assets

The proposed change clarifies the registration process when a registered cemetery is sold to a new operator based on Sub. HB 168.

1301:13-5-03 – Division staff recommends that this rule be amended.

Compliance

The proposed changes update the division's procedure when conducting routine compliance audits every five years and to update the record keeping requirements based on HB 168.

1301:13-7-01 – Division staff recommends this rule be adopted.

Criteria for eligibility

The rule provides the eligibility requirements for the cemetery grant program.

1301:13-7-02 – Division staff recommends this rule be adopted.

General provisions

The rule provides the basic policies and procedures for the grant program.

Grant applications

The rule provides the basic grant application requirements for the grant program.

Grant restrictions and requirements

The rule provides the restrictions and requirements for when a cemetery receives a grant, including how funds may be expended and a final report.

1301:13-7-05 – Division staff recommends this rule be adopted.

Cemetery grant advisory committee

The rule provides that the Ohio Cemetery Dispute Resolution Commission may appoint a seven voting member grant advisory committee to assist in the administration of the cemetery grant fund.

<u>1301:13-7-06</u> – Division staff recommends this rule be adopted.

Distribution of grant funds

The rule provides for the process of granting an award and distributing the funds.
