NOTIFICATION OF PUBLIC HEARING

Notice of hearing to amend Rule 4765-1-01, rescind Rules 4765-6-01, 4765-6-07, 4765-8-12, 4765-8-13, 4765-8-14, and 4765-12-01, and to adopt Rules 4765-18-01 through 4765-18-13 of the Ohio Administrative Code in accordance with Chapter 119. of the Ohio Revised Code.

Notice is hereby given that a hearing will be held by the State Board of Emergency Medical Services (the "Board") for the purpose of considering the proposed amendment, rescission, and adoption of the above-listed administrative rules.

As authorized in R.C. 4765.11, the Board proposes to amend, rescind, and adopt the above-listed rules of the Ohio Administrative Code (OAC). Rules regarding EMS instructors (4765-6-01, 4765-6-07, 4765-8-12, 4765-8-13, and 4765-8-14) are being rescinded and replaced by new Rules 4765-18-01 through 4765-18-13. The proposed changes are for the purpose of reorganizing and updating rules pertaining to EMS instructors so that the rules are more convenient for readers to access. In addition, Rule 4765-1-01 is being amended and Rule 4765-12-01 is being rescinded in order to condense definitions contained within OAC Chapters 4765-1 to 4765-19.

A public hearing on the proposed rules will be held Wednesday, August 20, 2003, at 9:00 a.m. in room 134 (first floor) of the Ohio Department of Public Safety, 1970 West Broad Street, Columbus, Ohio 43223.

Either written or oral testimony will be received at the hearing. Additionally, written comments received at the address below before the hearing will be treated as testimony.
