Rule 5101:2-16-55 entitled "Use of the JFS 01140 "Certificate of Authorization for Payment of Publicly Funded Child Care Services (COAP)" to contract with providers" has been amended to change the revision date of a form and to clarify language.

Rule 5101:2-16 71 entitled "Child care improper payments" has been amended to change the revision date of a form and to clarify language.
