Pursuant to section 119.03 of the Ohio Revised Code, the Ohio Department of Mental Health and Addiction Services (OhioMHAS) will hold a public hearing for the purpose of accepting testimony on the proposed changes to the rules governing opioid treatment programs (OTPs) in O.A.C. chapter 5122-40.

Rule	Summary of Major Changes
5122-40-01	This is the definitions rule for the chapter and updates are being made to incorporate definitions of new terms used in the chapter.
5122-40-05	This is the personnel rule. It is being updated to align the requirements for medical directors, program administrators, and mid-level practitioners with federal requirements. This change will allow for expansion of services and will not compromise patient safety. This section also defines the duties of the program director.
5122-40-06	This is the rule governing medication-assisted treatment administration. It is being updated to make take-home supply and emergency dosing requirements consistent with federal regulation. These changes will allow for more flexible medication administration with patients.
5122-40-07	This is the rule governing program policies and patient records. It is being updated to reflect the change in withdrawal management terminology and updated admission criteria. Counselor to patient ratio language is also being clarified.
5122-40-08	This is the rule governing the requirements OTPs have with respect to the state's drug database described in R.C. 4729.75 and the central registry system. The rule change clarifies that OTPs will provide direct contact information for central registry purposes rather a call center.
5122-40-09	This is the rule governing non-medication services. It is being updated to change language regarding counselors. The requirements for counseling

5122-40-10	This is the rule governing diversion. It is being updated to correct statutory references.	
5122-40-11	This is the rule governing toxicology screening. It is being updated to align the Administrative Code with federal toxicology requirements and remove duplicative language.	
5122-40-15	This is the rule governing medication units. It is being updated to remove geographic restrictions on mobile and non-mobile medication units.	

All other rules in the chapter have been filed as "no change" rules.
