Hearing Summary Report

Consolidated Summary of Comments Received

Please review all comments received and complete a consolidated summary paragraph of the comments and indicate the rule number(s).

The Ohio Realtors submitted a letter in support of the proposed IU rules. During the public hearing, comments submitted by the Ohio Manfuctured Homes Association (OMHA) addressed the IU program operations rather than requested specific changes to the rules. OMHA also submitted written questions requesting clarification of rules 4101:10-2-01, 4101:10-3-01, 4101:10-4-02, 4101:10-5-01 and 4101:10-9-01. The Board has already responded to OMHA comments regarding the IU program and is preparing a response to OMHA regarding the questions requesting clarification of the rules.

During public hearing Mr Jenkins, Mr. Baldauf, Mr. Larkin provided comment opposing the creation of the Level 2 residential electrical inspector certification in the Certification Rules (4101:7-3-01). Other than creation of Level 2 residential electrical inspector certification, Mr. Jenkins and Mr. Baldauf indicated support for the rule package. The Board left the record open for 7 days following the public hearing for any additional written comments to be submitted. During this time, Mr. Poe, Mr. Caskey, Mr. Baker and Mr. McClintock also submitted comments opposing the creation of Level 2 electrical inspector certification and Mr. Jenkins submitted additional written comments opposing Level 2 electrical inspector certification. During the public hearing, Mr. Harmon provided comment in support of the Certification Rules specifically related to the increase training opportunities. Mr. Dostal and Mr. Yates provided comment in support of the rules generally and specifically in support of the creation of the Level 2 residential electrical inspector certification. During the 7 days following the public hearing, Mr. Kowalczyk also submitted comments in support of the Certification Rules and the creation of the Level 2 electrical inspector certification. During public hearing, Mr. Montan submitted comments suggesting a compromise on the Level 2 residential electrical inspector by limiting the authority suggesting the Level 3 electrical safety inspector should inspect over 400 amps service, EVs and solar installsions.

No changes were incorporated into the IU rules as the comments were in support of or focused on operational concerns rather than specific rule provisions.

The Board refiled rules 4101:7-1-02 and 4101:7-3-02 of the Certification Rules to narrow the authority of the Level 2 residential electrical inspector requiring homes with a service over 400 amps or a three-phase service be inspected by the Level 3 electrical safety inspector in response to comments submitted opposing the creation of the residential electrical inspector and the specific comment submitted by Nicholas Montan suggesting limiting the authority of the Level 2 residential electrical inspector as a compromise. No other changes were incorporated in the Certification rules as the Board determined the retention of the Level 2 residential electrical inspector certification provides important flexibility in staffing and training for residential building departments and the receipt of other comments submitted in support of the package and/or in support for retention of the Level 2 residential electrical inspector certification.
