Regulatory Intent

1. Please briefly describe the draft regulation in plain language.

A: This amendment removes the one hundred fifty (150) mile limitation of regional heavy haul permits to reflect the changes made to Ohio Revised Code 4513.34 (A)(1)(c) in H.B. 62, effective 7/3/2019.

2. Please list the Ohio statute authorizing the Agency to adopt this regulation.

A: Ohio Revised Code 4513.34

A: No. There is nothing in the federal requirements as to mileage limitations.

A: Not applicable.

5. What is the public purpose for this regulation (i.e., why does the Agency feel that there needs to be any regulation in this area at all)?

A: This amendment will expand usage of regional heavy hauling permits.

6. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

A: The number of permits issued will gauge ODOT's impact on economic development, tracking incidents and issues will measure the impact of these permits on other highway users and ODOT can monitor the impact on the highway infrastructure.

Development of the Regulation

7. Please list the stakeholders included by the Agency in the development or initial review of the draft regulation.

A: This amendment is mandated by the change in the Ohio Revised Code that was stakeholder driven and not Agency driven. As a result, stakeholders were not contacted for the change to rule **5501:2-1-01 Definitions** which simply removed the phrase 'with the permitted trip not to exceed one hundred fifty miles.'

8. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

A: Stakeholders were instrumental in the removal of the mileage limitation in the Revised Code.

A: ODOT conducted a search of its rules and only identified this rule that contains the mileage limitation.

A: ODOT will plan to announce to stakeholders and post all relevant information via website and applicable permit forms.

Adverse Impact to Business

A: Ohio Revised Code requires Oversize/Overweight haulers to apply and receive a permit to transport on roadways and bridges in Ohio. These permits actually provide a useful and safe mechanism to simplify and aid in the movement of exceptional vehicles which would otherwise be illegal to move. However, the scope of the impacted business community includes all shippers and haulers within and through the state of Ohio that would need to transport Oversize/Overweight items. The hauler would be required to pay a permit fee to allow the travel of an Oversize/Overweight load. While there is a fee to acquire a permit, it is less burdensome than the previous rule imposing a 150-mile restriction.

15. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

A: This rule is mandated by statue. Oversize/overweight permits actually provide a useful and safe mechanism to simplify and aid in the movement of exceptional vehicles which would otherwise be illegal to move.

Regulatory Flexibility

- 16. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.
- A: There is no differentiation between a large or small business.
- 17. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

A: ODOT takes great effort to assure applicants submit the proper documentation. ODOT does not impose any penalty for paperwork issues.

18. What resources are available to assist small businesses with compliance of the regulation?

A: ODOT has a web page which provides all necessary information on the process to obtain an Oversize/Overweight permit. Additionally, the application system is web-based user-friendly software that is made available free-of-charge. There are instructional materials provided on the web page also. The ODOT Office of permits is available during normal working hours to assist applicants with permit processes.
