The Common Sense Initiative is established in R.C. 107.61 to eliminate excessive and duplicative rules and regulations that stand in the way of job creation. The General Assembly determined that the profession of dentistry required regulation and established a Board to license individuals and enforce the law and rules governing the practice of dentistry and dental hygiene in Ohio. These regulations allow the Board to carry out its statutory mission to ensure protection of the public by recognizing and remediating those dentists with practice deficiencies.

How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

The rule is not a quantitative regulation, nor does it impose a measurable (if any) quantitative burden on the licensees. The success of the regulation will be measured by the licensees understanding or legal objections to the rule.

No alternative regulations were considered by the agency since it was determined that the rules worked as intended by legislature.

The Board did not see an application for the rules in this package to be performance-based.

The five-year rule review process is conducted with a focus on eliminating obsolete, unnecessary, and redundant rules and avoiding duplication. In addition, meetings with interested parties help to ensure that these rules do not duplicate any existing Ohio regulation.

15. Please describe the Agency's plan for implementation of the regulation, including any measures to ensure that the regulation is applied consistently and predictably for the regulated community.

The Board will continue to use its website to educate and update licensees on its rules. Board employees provide informational presentations to stakeholder organizations and groups of dental personnel to keep the dental profession apprised of current regulations. Stakeholder organizations also ensure that rules are provided to their members through communications

and CE. Staff training is conducted for rule changes to ensure that regulations are applied consistently.

Adverse Impact to Business

OAC Chapter 4 715-40 impacts individual licensees with recognized practice deficiencies.

Identify the nature of all adverse impact (e.g., fees, fines, employer time for compliance,); and

Licensees participating in the QUIP program are required to pay the cost of the remediation education. Cost of remediation education ranges from \$150/hour at The Ohio State University College of Dentistry to \$200/hour at Case Western Reserve University College of Dental Medicine. Additionally, licensees entered into remediation education may incur costs for educational materials if applicable.

Quantify the expected adverse impact from the regulation.

The adverse impact can be quantified in terms of dollars, hours to comply, or other factors; and may be estimated for the entire regulated population or for a “representative business.” Please include the source for your information/estimated impact.

Typically, the cost of the remediation education is \$150-\$200/hour depending on the licensee's choice of remediation education provider.

17. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

The Board is solely responsible for ensuring that only competent and safe practitioners are permitted to practice dentistry in Ohio.

Regulatory Flexibility

18. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

The rules exist for the sole purpose to provide the Board the authority to discipline licensees for substandard practice which allows the Board to fulfill its statutory mission of protection
